**AN ORDINANCE FURTHER AMENDING SECTION 3 OF MUNICIPAL ORDINANCE NO. 04, SERIES OF 2019, AS AMENDED BY MUNICIPAL ORDINANCE NO. 02, SERIES OF 2020, OTHERWISE KNOWN AS “AN ORDINANCE SETTING THE NEW DAILY WAGE RATE FOR POSITIONS OF JOB-HIRE AND CONTRACTUAL EMPLOYEES OF THE MUNICIPALITY OF NUEVA VALENCIA, GUIMARAS, AMENDING FOR THE SAID PURPOSE ALL PRIOR ORDINANCES”**

**WHEREAS**, Section 447 (a)(1)(viii) of the Local Government Code of 1991 empowers the Sangguniang Bayan to determine the positions and salaries, wages, allowances and other emoluments and benefits of officials and employees paid wholly or mainly from municipal funds and provide for expenditures necessary for the proper conduct of programs, projects, services, and activities of the municipal government;

**WHEREAS**, on August 22, 2019, the Sangguniang Bayan enacted Municipal Ordinance No. 04, Series of 2019 setting the new daily wage rate for job-hire and contractual employees of the Municipality of Nueva Valencia, Guimaras;

**WHEREAS**, on January 8, 2020, the Sangguniang Bayan amended Municipal Ordinance No. 04, Series of 2019, pursuant to Municipal Ordinance No. 02, Series of 2020 by including the positions of Tax Mapping Aide and Emergency Medical Technician;

**WHEREAS**, on February 9, 2021, the Local Chief Executive, Honorable Emmanuel C. Galila requested for the passage of an ordinance amending Section 3 of Municipal Ordinance No. 04, Series of 2019 to include the following as contractual positions:

<i>Position Title</i>	<i>Rate</i>
1. Medical Officer I (Doctor)	25,000.00 for 64 hours per month
2. Medical Officer II (Doctor)	30,000.00 for 64 hours per month
3. Medical Officer III (Doctor)	40,000.00 for 64 hours per month

**WHEREAS**, the amendment is deemed imperative in order to ensure the delivery of effective and efficient health services in accordance with Section 17(b)(2)(iii) of the Local Government Code of 1991;

**NOW THEREFORE**, be it ordained by the Sangguniang Bayan of Nueva Valencia, Guimaras in a session assembled, that:

**SECTION 1. AMENDATORY CLAUSE.** – Section 3 of Municipal Ordinance No. 04, Series of 2019 is hereby further amended to read as follows:

“**SECTION 3.** The new rates for the wages of job-hire and contractual employees of this municipality shall be as follows:

**SECTION 3. SEPARABILITY CLAUSE.** – If any provision, section or part of this Ordinance is held invalid or unconstitutional by any court of competent jurisdiction, the other provisions not affected thereby shall continue to be operative.

**SECTION 4. EFFECTIVITY CLAUSE.** – This ordinance shall be effective in accordance with the provisions of RA 7160 otherwise known as the Local Government Code of 1991.




