AN ORDINANCE AMENDING SECTION 3 OF MUNICIPAL ORDINANCE NO. 04, SERIES OF 2019, OTHERWISE KNOWN AS “AN ORDINANCE SETTING THE NEW DAILY WAGE RATE FOR POSITIONS OF JOB-HIRE AND CONTRACTUAL EMPLOYEES OF THE MUNICIPALITY OF NUEVA VALENCIA, GUIMARAS, AMENDING FOR THE SAID PURPOSE ALL PRIOR ORDINANCES”

WHEREAS, on August 22, 2019, the Sangguniang Bayan enacted Municipal Ordinance No. 04, Series of 2019 setting the new daily wage rate for job-hire and contractual employees of the Municipality of Nueva Valencia, Guimaras;

WHEREAS, the above-mentioned ordinance is pursuant to Section 447 (a)(1)(viii) of the Local Government Code of 1991 which empowers the Sangguniang Bayan to determine the positions and salaries, wages, allowances and other emoluments and benefits of officials and employees paid wholly or mainly from municipal funds and provide for expenditures necessary for the proper conduct of programs, projects, services, and activities of the municipal government;

WHEREAS, the Local Chief Executive, in his letter dated January 2, 2020, requested for the passage of an ordinance setting the daily wage rate for Tax Mapping Aid with a rate of 400.00 per day and Emergency Medical Technician (EMT) with a rate of 450.00 per day;

WHEREAS, after thorough and judicious deliberation, this august body deemed it imperative to grant the request, the position of Tax Mapping Aide being necessary for a more effective and efficient tax assessment in the municipality, while the Emergency Medical Technician is necessary for immediate lifesaving care and interventions for critical patients being catered by the municipal emergency vehicles;

NOW THEREFORE, be it ordained by the Sangguniang Bayan of Nueva Valencia, Guimaras, that:

SECTION 1. AMENDATORY CLAUSE. – Section 3 of Municipal Ordinance No. 04, Series of 2019 is hereby amended to read as follows:

“**SECTION 3.** The new rates for the wages of job-hire and contractual employees of this municipality shall be as follows:

SECTION 3. SEPARABILITY CLAUSE. – If any provision, section or part of this Ordinance is held invalid or unconstitutional by any court of competent jurisdiction, the other provisions not affected thereby shall continue to be operative.

SECTION 4. EFFECTIVITY CLAUSE. – This ordinance shall be effective in accordance with the provisions of RA 7160 otherwise known as the Local Government Code of 1991.


