**AN ORDINANCE AUTHORIZING THE MUNICIPAL MAYOR HON. EMMANUEL C. GALILA THE USE OF SAVINGS FOR AUGMENTATION OF APPROPRIATION FROM AND TO VARIOUS ITEMS OF PERSONAL SERVICES TO VARIOUS OFFICES OF THE LOCAL GOVERNMENT UNIT OF THE MUNICIPALITY OF NUEVA VALENCIA, GUIMARAS**

Be enacted by the Sangguniang Bayan of Nueva Valencia in its regular session that:

**SECTION 1 – AUTHORITY** – pursuant to Section 336 of RA 7160 otherwise known as the Local Government Code of 1991, the authority is hereby granted to the Municipal Mayor, the Use of Savings and Augmentation of Appropriation.

**SECTION 2 – SOURCE OF AUGMENTATION & ITEM TO BE AUGMENTED** – The appropriation from various items of the Personal Services in the amount of Two Million Five Hundred Two Thousand Seven Hundred Fifty-Five Pesos (Php 2,502,755.00) shall be augmented to the following items of the different offices of the LGU of Nueva Valencia, including the release of the First Tranche of Salary Standardization Law V which shall retroactively take effect on January 1, 2020 to wit:

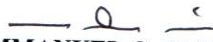

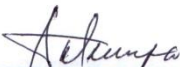

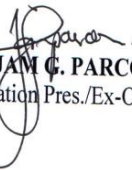
